#### POLICY REQUIREMENT

##### Policy Coverage:

Company intends to take to Insurance policy to cover all the risk associated with respect to the owner and the contractor for the ongoing project work. The estimated time for the completion of the project is 10 months.

The policy should cover the following:

- (i) Material Damage: Covering physical loss, damage or destruction of the property insured by any cause.
- (ii) Third Party Liability: Covering the legal liability falling on the insured contractor as a result of bodily injury or property damage belonging to a third party.
- (iii) Owner Surrounding Property for INR 10 Crores on the whole.
- (iv) Removal of Debris, Earthquake and STFI to be covered.
