Understanding is correct. Good Quality Soil (Earth) is required in this case.

5	In scope of work it is mentioned that HAZOP and HAZID shall be performed for all operations.	Please clarify whether cost for the same has to be added in our quote.	Bidder shall consider HAZOP study in his scope of work and shall quote appropriate.
6	Scada/ PLC software and Hardware Integration with existing system	Items for supply and laying of control cables is there but there is no separate item for Scada, PLC and software and hardware integration. Items beyond laying of signal and control cables should be in the owners scope.	Supply and Laying of control cable / signal cable, SCADA, PLC and software / hardware integration is not in the scope of Bidder.
